





Dear friends and colleagues,

We are delighted to welcome you at the ILA Regional Conference 2013 at Cape Sounion for three days of reflexion by the sea under the general theme:

**Imperium Juris: Governance, Trade, Resources**

In this Regional Conference, aptly taking place at the crossroads between the developed and the emerging world in times of global crisis, we intend to concentrate on the Rule of Law as manifested in the areas of Trade and Resources and their related Governance issues.

It is in this context that we intend to explore in this Regional Conference cutting-edge issues within each field but also questions arising from the interplay between them. Trade will concentrate on two ever-topical areas. The WTO offers an excellent example of a self-contained regime, encompassing a wide array of activities within a single institutional framework, complete with its own dispute settlement system. Shipping, on the other hand, offers the archetype of a decentralised yet universal system, which manages to provide effective solutions to evolving problems with a minimum of enforcement requirements. How these two faces of reality in trade project into a more comprehensive system of trade governance is the natural query arising from their parallel development and invites further reflexion. Recourses offer a much less regulated environment and a far greater potential for the concurrent application of different, often widely diverse and occasionally contradictory sets of rules. As their market share increases, so does the role they are called to play in world affairs – and commensurably their significance and normative impact as well. Governance will provide both the background discussion on the architecture of international law and the prospects of further development or, more modestly, simply covering the fissures of a system bursting at the seams.

We consider our chosen subject a theme specific enough and yet conducive to a holistic approach, reflecting the background of general international law, private and public, against which Trade, Resources and their Governance operate. We invite academics and practitioners to contribute their experience and expertise on the matter and join the members of ILA Committees and Study Groups in further exploring areas of cross-fertilization in these important and continuously evolving fields.





## The Human Right to Water Significance, Legal Status and Implications for Water Allocation Inga T Winkler





This in turn necessitates an examination of the relationship between international law and power. Thus rather than studying international law as a system of rules that purports to govern, or at least constrain, the international community, this book considers the actual effects of international law upon international disagreements.




## The Interception of Vessels on the High Seas Contemporary Challenges to the Legal Order of the Oceans Efthymios Papastavridis

The principal aim of this book is to address the international legal questions arising from the 'right of visit on the high seas' in the twenty-first century. This right is considered the most significant exception to the fundamental principle of the freedom of the high seas (the freedom, in peacetime, to remain free of interference by ships of another flag). It is this freedom that has been challenged by a recent significant increase in interceptions to counter the threats of international terrorism and WMD proliferation, or to suppress transnational organised crime at sea, particularly the trafficking of narcotics and smuggling of migrants. The author questions whether the principle of non-interference has been so significantly curtailed as to have lost its relevance in the contemporary legal order of the oceans.

**Efthymios Papastavridis** is a part-time Lecturer, University of Thrace, Faculty of Law and Research Fellow at the Academy of Athens. He was appointed Director of the 2012 Centre for Studies and Research in International Law and International Relations (English-Speaking Section), The Hague Academy of International Law.


## The International Court of Justice Robert Kolb






